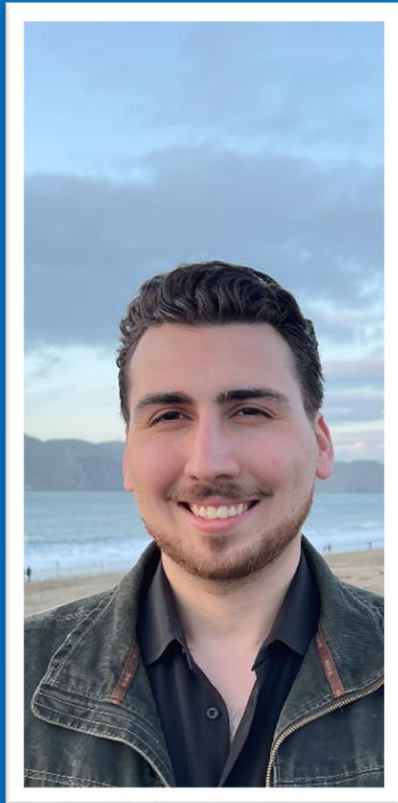

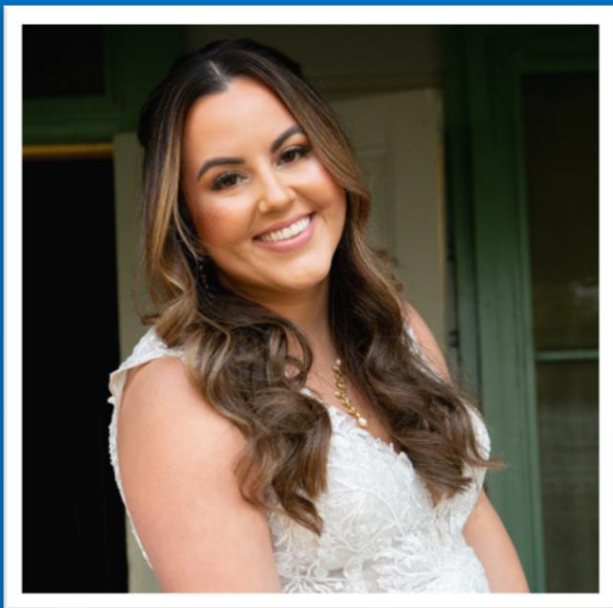

I think my favorite thing about MCL is the small class sizes. Moving along with one cohort grows a sense of community.

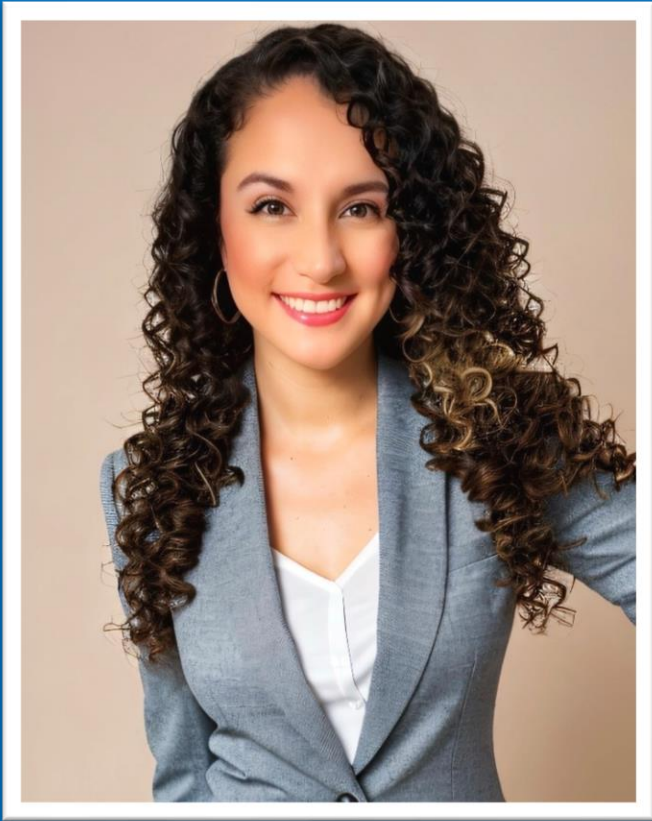
