Please review your degree requirements and this course catalogue *before* filling out the Clinical Course Application.

Your registration application is due **SUNDAY, March 15, 2026**. All applications will be reviewed after the deadline, without regard to the order in which they were received. Accordingly, please take your time in carefully reviewing these materials and preparing your application. You are only registering for the SUMMER 2026 semester at this time.

All courses in this catalogue are 1 unit. All courses are open to students at all campuses and meet on Zoom, unless otherwise mentioned.

Please note that “Core Mediation” is a required course for all students. You may enroll in Core Mediation after completion of all first year required courses. Core Mediation is not part of the Clinical Course Application, so you may register for it on your own, in Populi.

| <ul style="list-style-type: none"> <li>• Core Mediation (2 units)</li> <li>• 2 additional clinical units</li> </ul> | <ul style="list-style-type: none"> <li>• <u>You Have Options</u>: Your 2 additional units made be satisfied by taking clinics (listed below) and/or by completing an approved Internship.</li> <li>• <u>Be Prepared</u>: We <i>strongly encourage</i> you to take “Introduction to Community Legal Services” (ICLS) before enrolling in <i>either</i> a clinic or a Mediation Practicum class.</li> <li>• <u>Mediation</u>: We have ONE mediation practicum class for the Spring semester: MCL Mediation Practicum. It is open to students from all campuses and meets on Zoom. You must complete Core Mediation before taking a mediation practicum class. In addition, as noted above, we strongly encourage you to take ICLS beforehand. The MCL Mediation Practicum involves more independent work, making it an advanced course. We recommend taking other clinics first before taking a MCL Mediation Practicum class.</li> <li>• <u>Internships</u>: Completing an internship with a court, law firm, or agency is a great way to get legal training and build connections with your local legal community. Internships are also an opportunity to demonstrate your talents and skills as a future attorney. Successful interns sometimes even receive job offers!<br/>       But a mediocre or unsuccessful internship could have the opposite effect. We <i>strongly encourage</i> you to complete other clinical courses at school before applying for an internship. Internship Program Guidelines, Instructions, and Forms can be found in the “Forms &amp; Policies” section of the school website.</li> <li>• <u>Make It Your Own</u>: Whether you want to try everything, or build experience in a particular area, we encourage you to start planning your clinical education goals early. | Thursday<br>12:00-1:00    | MCL<br>Mediation<br>Practicum                              | Hall &<br>McCorkle | Students in Mediation Practicum mediate small claims and civil harassment cases for the Monterey County Superior Court. Mediations primarily take place remotely, via phone or Zoom, but local students may participate in person during the small claims calendar at the Marina courthouse. This class meets from 12:00-1:00 on Thursdays at least seven times during the semester. Mediations are conducted outside of class time and can be scheduled independently during normal business hours. The professors provide close guidance and supervision through the mediation process.
