



SCHOLARSHIP APPLICATION FORM

Please check the scholarship box to which this application applies.

☐ **Academic Excellence Scholarship - Two thousand dollars (\$2,000.00)**

A minimum cumulative GPA of 78% is required, and the applicant must be a KCCL student having completed at least 20 units of KCCL study.

OR

☐ **Overall Achievement Scholarship – One thousand five hundred dollars (\$1,500.00)**

A minimum cumulative GPA of 75% is required, and the applicant must be a KCCL student having completed at least 20 units of KCCL study.

OR

☐ **Veteran/First Responder – One thousand five hundred dollars (\$1,500.00)**

A minimum cumulative GPA of 72% is required, and the applicant must be a KCCL student having completed at least 20 units of KCCL study.

***US MILITARY: must have been honorably discharged from U.S. military services or in reserve service.**

***FIRST RESPONDER: must have had one year or more as a first responder before or during law school. First responders are police officers, firefighters, and paramedics.**

Kern County College of Law offers three (3) separate scholarships for each school year. The application window is open from the first day of each fall semester until midnight on the second Sunday in September. Submit applications to the Campus Administrator, Bobbie Hernandez (bhernandez@kerncountylaw.org). Late applications are not considered. A 3-member committee which will include a KCCL professor, an MCL administration member, and a Kern County Bar Association member, will consider the application. The committee's decisions will be final. Students may apply yearly for any scholarships for which they meet minimum qualifications; however, no student will receive more than one scholarship per year. A separate application form is required for each scholarship for which you want to be considered. *No financial questions are asked.*
