

Final Exam Disbursement

- Stevie asked Dean Baltodano a question that has pressed on some students regarding the long, tedious process that students have to go through to see their final exams and scores.
 - Students have to send the school an email and fill out a form, then the student has to scan the exams themselves. Why not have a copy ready for each student?

Dean Baltodano said:

- It is a security issue—cannot have original exams leave the premises.
- Exams are not already scanned into the system. There is a process. If a student wants to see their graded exam, they have to come and scan it or copy it themselves.
 - When the school says that exams are ready, it means that all professors have submitted the grades and all grades are input into Populi. It does not mean that the exams are scanned and ready for distribution. They are all hard copies.
 - The only students who may get a scanned copy are hybrid students.
- Another more specific question Stevie asked Dean Baltodano was if it was possible for the school to scan the exam for the student who filled out the form, and have it ready for them to pick up when they arrive?
 - Dean Baltodanto said it was not possible to do this because of the amount of time it would take Marian to do this. If the student or students have any further questions about this, they should contact Marian.

 Charles commented that the new printer should alleviate the scanning and printing issues students have had in the past.

 - Mikayla commented that ID cards should fall under administrative policy. It would be uniform for all students and should not come out of SBA fund. Mikayla would like to bring this subject up to Marian or the Dean.
 - In response to Mikayla, Stevie commented that this is not a new subject, students want an ID, but unfortunately, the responsibility of providing a physical ID to the students will

not be handled by the main administrative decision makers. Purchasing an ID machine for the school is also not a possibility at this time. Purchasing an ID machine was not approved in the past, according to information provided to Stevie by Seth.

- Stevie recently sought a quote from Poor Richard's Press in San Luis Obispo and they are quite expensive. They quoted \$544 for 15 ID cards.
- Stevie will inquire with other SBAs to see if pooling funds together is a possibility to purchase an ID machine and work together to produce them, or maybe have administration produce them.
